- Not engage in verbal, relational, or physical bullying or cyber bullying.
- Not touch or invade another singer's personal space without permission.
- Be aware of SCC's policies and procedures regarding behavior.
- Abide by the policies and procedures of SCC.
- Support singers who have been victimized by bullies.
- Speak out against verbal, relational, and physical bullying and cyber bullying.
- Notify a parent, director, or office staff when bullying does occur.
- Be a good role model for other singers.

**Waiver of Liability**

We, the parent/guardian and singer, on behalf of ourselves and each of our heirs, executors and administrators, agree to release and hold harmless Sacramento Children's Chorus (SCC) and each of its officers, directors, agents, employees, administrators, volunteers, representatives and assigns from any and all right, claim or liability for any and all damages, injuries, costs or expenses incurred by the undersigned singer or his/her parent/guardian during the course of, as a result of, or in any way connected with the undersigned singer's or parent/guardian's participation in SCC activities, whether such damages, injuries, costs or expenses may arise from circumstances outside the control of SCC, from acts of any other participants in SCC, or from the acts of SCC or any of its officers, directors, agents, employees, volunteers, representatives and assigns, including negligence or carelessness of same. This agreement extends to all claims of every kind and nature whatsoever, whether known or unknown, including an express waiver of any rights or benefits either of us may have under section 1542 of the California Civil Code relating to the release of unknown claims. By signing below, we acknowledge that we each have read and understand the provisions of this waiver of liability.

**Photo, Video and Audio, Release**

I understand and agree that during any SCC activities, my singer may be photographed, video recorded, or audio recorded. I understand and agree that SCC shall hold the sole copyright to any images or recordings of the undersigned singer, and I hereby waive any and all claims to such images or recordings, including but not limited to ownership or copyright claims.

I further agree that my singer's image and voice, including photos, videos, audio recordings and any other reproduction of the undersigned singer's likeness may be used by SCC for any purpose, including but not limited to marketing, fundraising, external news or entertainment media, publicity, archiving, or any other purpose, without payment or any other compensation, now or in the future. I understand the SCC will not use the singer's name without my express approval. I hereby release SCC and its officers, directors, agents, employees, volunteers, representative and assigns from any expectation of confidentiality, except in the matters of medical or financial matters, for the undersigned singer.

In the event that any provision of this contract is held unenforceable, all remaining provisions shall remain in full force and effect.

- Should the child drop for non medical or emergency reasons during the course of the session – any paid for unused class tuition is not refundable.
